

Resolution No. 128/2022 of the Budapest Stock Exchange Ltd.

With regard to the ordinary shares (ISIN: HU0000176722) of the issuer **DM-KER Public Company Limited by Shares** (registered seat 2310 Szigetszentmiklós, Csepeli út 22.; hereinafter referred to as 'Issuer'), listed on the Budapest Stock Exchange as of March 24, 2022, according to the application for the commencement of trading submitted by the Issuer, the Budapest Stock Exchange Ltd.
